The tender will be opened on 08 Nov 2024 at 1100 hours at Army Public School, Raiwala. Bidders will be present at Army Public School, Raiwala on 08 Nov 2024 at 1045 hours.
- 3. The disposal of vehicle shall be strictly on "AS IS WHERE IS AND WHATEVER IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the school. Bidders need to submit earnest money for Rs. 20,000/- each along with bid. The earnest money can be deposited by Bank Draft/Banker's Cheque in favour of "Army Public School Raiwala, payable at Raiwala". The Bank Draft/Banker's Cheque should be attached with the quoted bid, failing which the bids will not be considered at all.
